### ANNEX C: ALTERNATE LOCATION/ FACILITY INFORMATION

### I. PRIMARY ALTERNATE FACILITY

#### A. Description

The primary alternate for the administrative function is the Manatee County Public Safety Center, ECC Room 2401, 2191 47<sup>th</sup> Terrace East, Bradenton. This location provides fully operational communication and office capabilities. The primary alternate for animal operations in a non storm or flood related event is the Manatee County Fairgrounds (Geographic Coordinates - 27 31.61N, 82 34.84W; NGS 17R LL 439 458). This facility provides animal confinement cages and communications which could allow Animal Services to be fully operational. The primary alternate facility for animal operations during a flood or storm event will be the Dog Leg Dog Park at Buffalo Creek (Geographic coordinates - 27 34.76N, 82 28.89W; NGS 17R LL 537 514).

This facility provides water and a large fenced area for animal confinement. Animal Services would need to provide temporary individual fencing, portable cages and portable tents for shelter. Refer to maps on page C-3, 4 for directions from Animal Services to the Alternates.

#### B. Supplies and equipment

Refer to equipment matrix beginning on page C – 5. Movement of equipment not located at the alternate location is the responsibility of Jerry Hill, the Logistics Officer in time of disaster. Jerry Hill will be responsible for notifying our Administrative staff in order to purchase or locate any equipment or supplies not available at the alternate location using existing County purchasing policies. Medications and controlled substances will be secured and maintained in coolers.

### C. Capabilities

While a move of an average of 160 dogs and cats would be a task within itself, our staff will perform the necessary tasks in order to effectuate the move as safely and expeditiously as possible. Either location above will be able to satisfy our needs.

### **II. SECONDARY ALTERNATE FACILITY**

A. Description


The secondary alternate for animal operations is Happy Tails Dog Park at G.T. Bray Park. This location will be used primarily as a staging area, post event. 

## **Animal Services to Fairgrounds**


