Florida is a major agricultural producer and exporter, with \$8.88 billion in agricultural products sold annually as of the latest USDA agricultural census. Agriculture makes up one of the largest portions of Florida's \$1.2 trillion gross domestic product, and it is critical that this engine of our economy has the resources they need to continue to operate, which includes people and organizations like you.

These events emphasize the importance of working together as a SART team to create one coordinated and efficient response when disaster strikes. Florida SART is a multi-agency coordination group consisting of governmental and private entities dedicated to strengthening all-hazard disaster capabilities through partnerships. 
COLONEL LEE ADAMS

FLORIDA SARC ADMINISTRATOR



TRAINING DESCRIPTIONS

ANIMAL TECHNICAL RESCUE AWARENESS LEVEL

MEDITERRANEAN ROOM

Presented by the UF College of Veterinarian Medicine (UF CVM VETS Team). This is the foundation course for more advanced levels of our training program. This course is eight (8) hours of Continuing Education credit. This course has been designed to bring together various agencies in a community to aid in networking and connecting resources. Participants will get an overview of the need for animal technical rescue, resources to activate, how to assist rescue teams, scene safety in animal emergencies, and common techniques and tools used in responses. Target audience is livestock owners, Fire/Search and Rescue, Animal Control, Veterinary Professionals, other livestock stakeholders, and Extension Agents.

SMALL ANIMAL EMERGENCY AND DISASTER SHELTERING COURSE — AWARENESS LEVEL DATE AND BLUE PALM ROOM

Presented by the FL State Animal Response Coalition (SARC). This awareness level class will give you knowledge, expertise and practical experience you need to work in an emergency/evacuation animal shelter. This course is eight (8) hours of Continuing Education credit. This course is also required to become a deployment member of FL SARC's incident response team. This course is FEMA approved and certified/accredited by the Florida Division of Emergency Management.

GO 191: EMERGENCY OPERATIONS CENTER/INCIDENT COMMAND SYSTEM INTERFACE MAJESTIC PALM ROOM

This course meets requirements for the FEMA Advanced Professional Series (APS) certificate. The goal of this professional development course is to enable the students to develop an effective interface between the Incident Command/Unified Command and the Emergency Operations Center by applying the National Incident Management System principles. It is intended for federal, state, tribal, territorial, local level, private industry, volunteer, and non-governmental emergency management personnel who are active in a community's ICS and EOC activities. Prerequisites: IS-100, IS-200 (or IS-2200), IS-700, and IS-800.

ANIMAL ALL HAZARDS AWARENESS

MEDITERRANEAN ROOM

Presented by Dr. L. Garcia from the UF CVM VETS Team. This series of presentations is designed to support animal and agricultural first responders by enhancing their preparedness, response capabilities, safety, and well-being. Topics include:

"How to prepare for disaster":Preparing yourself, family, pets, home, and workplace for anticipated and unanticipated disasters.

"Common disasters and Response types":Discusses disaster types, their impacts on animals, and adaptable response strategies. Includes UF VETS resources.

"Emergency Responder safety for hoarding cases": Highlights field adaptations and supplies for managing animal hoarding cases.

"Compassion fatigue Strategies":Helps animal care professionals recognize and address compassion fatigue and build sustainable self-care habits.


