## Agroterrorism: Florida Law Enforcement's Role

By the time former Health and Human Services Secretary Tommy Thompson said, "For the life of me, I cannot understand why the terrorists have not attacked our food supply because it is so easy to do," numerous Federal, state, and local agencies were already working on agricultural emergency planning and response efforts.

Years later, in 2014, Major Ben Burns with the Office of Agricultural Law Enforcement (OALE) at FDACS wrote a thesis entitled [Florida Law Enforcement's Role in Agroterrorism](#), which sought to examine progress made in protecting the State from attack.

In Major Burns' research, he cited National Institute of Justice gaps, stating, "The element that is missing from Florida's capabilities is having a law enforcement

component intrinsic to their response."

Further, "This missing element results in two gaps. First, there is no criminal investigation element as an intrinsic part of an animal disease response event. Second, there is no ability to immediately enforce quarantines, stop movements, and, if needed, to enforce public order at the scene of the outbreak."

Burns speaks to the need of additional policy changes in Florida, recommending that agroterrorism training be mandatory for all OALE sworn personnel.

## UF Veterinary Emergency Treatment Service (VETS) Update

## SART Partners Attended All Hazards Planning for Animal, Agricultural, & Food Related Disasters Course



The Florida State Agricultural Response Team (SART) and Florida's Integrated Rapid Response Team (FLIRRT) hosted *All Hazards Planning for Animal, Agricultural, & Food Related Disasters* training course on February 28, 2018. This management level course provided background information needed to lead a multi-agency team of emergency planners in the development of an Emergency Support Function (ESF) annex for animal, agriculture, and food-related (AAF) disasters. This Department of Homeland Security certified training can then be used to supplement a community's existing Emergency Operation Plans.

Participants included FDACS' Division of Animal Industry, Division of Food Safety, Office of Agricultural Law Enforcement, and Office of Agricultural Water Policy; SART partners included FLIRRT, Florida Veterinary Medical Association, University of Florida College of Veterinary Medicine, and USDA. The training provided background information, resources, and case studies for constructing AAF disaster response plans for application in the event of an AAF emergency.

The course was instructed by the University of California-Davis' Western Institute for Food Safety and Security.



## Florida Forest Service Encourages Use of BurnTools App

As the State prepares for wildfire season, SART reminds you to download the "FLBurnTools" mobile app. This service aims to inform the public about drought, wildfire danger and wildfire activity. Prescribed burn practitioners can also use the app to plan and submit authorization requests. The "FLBurnTools" app is now available in both Apple's [App Store](#) and on [Google Play](#).

The Florida Forest Service's prescribed fire program is a nationwide leader, treating more than 2.1 million acres last year and providing approximately 88,000 burn authorizations annually. In addition to administering Florida's prescribed fire program, the Florida Forest Service responds to wildfires during Florida's year-round wildfire season.

The "FLBurnTools" app provides the following tools:

- Drought information
- Interactive fire maps
- Wildfire information
- Burning authorization requests
- Smoke dispersion models
- Spot weather forecasts

## Training Opportunity: Emergency Pet Friendly Sheltering and PETS Act Reimbursement for Counties

A new course, "Emergency Pet Friendly Sheltering and PETS Act Reimbursement for Counties," will be offered at this year's 2018 Governor's Hurricane Conference (FLGHC) in West Palm Beach. This 1.5 hour course will be offered two times during the conference. The course will be taught by SART's LeiAnna Tucker and SARC's Consie von Gontard.

**Course Description:** Disasters can have a devastating effect on human and animal life, including family pets. This course will explain the difference between emergency sheltering, co-located sheltering and Pet Friendly sheltering, along with the pros and cons of each type of shelter. Through best management practices, pet evacuation and sheltering operations can provide proper care for these animals and keep families together. The PETS Act and Post-Katrina Emergency Management Reform Act mandates state and local jurisdictions seeking FEMA Public Assistance to incorporate provisions in their emergency plans for evacuating and sheltering people with household pets and service animals facing disasters. This course will focus primarily on responsibilities with the setup, maintenance, animal care, and teardown of emergency Pet Friendly shelters. This training will also discuss how the Pet Evacuation and Transportation Standards Act (PETS Act) provides counties reimbursement for eligible expenses associated with setting up pet-friendly shelters and transporting those pets, if needed.



## UF/IFAS Provides Biosecurity and Biological Risk Management for Livestock Enterprises Resource



On March 1, one premises in Suwannee County was placed under quarantine for clinical signs and a positive PCR test result for Strangles. This is the eighth case of Strangles for Florida in 2018.

### **Kanan Enterprises Conducts Voluntary Recall of Southern Grove Unsalted Almonds**

Last month, Kanan Enterprises announced the voluntary recall of Southern Grove Unsalted Almond 14 oz., Best By SEP 25 2018 KN due to the presence of wheat and soy that are not listed as ingredients. People who have an allergy to wheat or soy run the risk of a serious or life-threatening allergic reaction if they consume these products. No adverse reactions have been reported associated with this recall. The product was distributed throughout Florida and other states.

## **Enrollment Open: Multiple Courses for Small Animal Emergency Sheltering**

The Florida State Animal Response Coalition has upcoming opportunities for their Operations Level 2 Small Animal Emergency Sheltering and Awareness Level courses.

When disaster strikes, the team of trained volunteer responders will be there to shelter and protect Florida's companion animals.

The Awareness Level 1 course gives students the knowledge necessary to work in an emergency animal shelter. This class provides expertise and practical experience required to become a professional disaster animal responder. The Awareness Level Small Animal Emergency Sheltering course is certified by the Florida Department of Emergency Management and is required to respond in Florida to help companion animals and their owners during a disaster.

The Operations Level 2 course gives many new job options, in addition to leadership skills and team lead opportunities. This course expands upon information covered in FL-003-RESP and ICS-100 courses. These earlier courses are prerequisites for FL-607-RESP.

Course topics include: Personal Preparedness, Overview of the Incident Command System, Deployment Preparedness, Assisting in Shelter Setup, Daily Care and Feeding, Proper Cage Cleaning and Disinfection, Animal Behavior, Stress Management, Zoonotic Diseases, and Personal Safety.

A special section dedicated to feed and food emergency planning and response.


Florida's Integrated Rapid Response Team (FLIRRT) is a multi-agency coordination group responding to feed and food emergency under the Rapid Response Team Food and Drug Administration (FDA) Cooperative Grant Program.

Florida is one of 21 states participating in this program, beginning in 2008. Partner agencies include the FDA, the Florida Department of Health, and Florida Department of Business and Professional Regulation.

FLIRRT consists of technical experts in food manufacturing, food inspection, environmental health, and epidemiology. FLIRRT is an active partner in Emergency Support Function 11 (Food and Water) at Florida's State Emergency Operations Center.

- Team members from FLIRRT attended the 7th Manufactured Food Regulatory Program Alliance (MFRPA) Meeting January 29–February 1 in Albuquerque, New Mexico. Summer Williams, Patty Lewandowski and Jamie DeMent presented a panel discussion on "Using Technology to Enhance Surveillance and Response." Topics included GIS mapping for response, Whole Genome Sequencing in the Food Lab, and social media for complaint response. Summer also presented the FLIRRT online recall audit check module during the roundtable session. Matthew Coleman presented on contract inspections during a breakout session.
- Summer Williams participated in the 2018 St. Lucie Nuclear Power Plant FEMA Evaluated Exercise at the State Emergency Operations Center on February 14, 2018. Summer represented the Division of Food Safety under Emergency Support Function 11 (Food and Water). The scenario included a radiological disaster at the St. Lucie Power Plant. GIS mapping was used to exercise the use of gathering information on food facilities in the area of the disaster.
