Hurricane Michael Upgraded to a Category 5 Storm

Remember last year's destructive Hurricane Michael? The one that, at the time, was reported as a Category 4 storm? Well, think again.

Post-storm analysis estimates show the storm had sustained winds high enough to elevate a notch higher, making it the first Category 5 hurricane to strike the contiguous United States since Andrew in 1992.

Scientists at NOAA's National Hurricane Center conducted a detailed post-storm analysis on all the data available for Hurricane Michael and have determined that the storm's estimated intensity at landfall was 140 knots (160 mph).

This final wind intensity is a 5 knot (5 mph) increase over the

operational estimate and makes Michael a category 5 storm on the Saffir-Simpson Hurricane Wind Scale at the time of landfall on October 10, 2018, near Mexico Beach and Tyndall Air Force Base, Florida.

In advance of the storm, Governor Rick Scott declared a state of emergency for 35 of Florida's 67 counties.

In the aftermath, at least 17 people died of storm-related accidents and more than 1.3 million homes and businesses were without power.



SART Partners Coordination Call Announced

A SART Partners Coordination Conference Call is scheduled for Monday, May 6, at 2:00 p.m. to participate in the Statewide Hurricane Exercise taking place in Tallahassee at the State Emergency Operations Center. The call will be held for SART partners to participate in the exercise scenario with Emergency Support Function 17 and practice incident prioritization and response actions for a major hurricane event in Florida.

UF VETS in Action...



The University of Florida (UF) Veterinary Emergency Treatment Service (VETS) Animal Technical Rescue team provided response for a cow trapped in a dry septic tank on April 17th in Putnam County, Florida. Also involved in rescue efforts were Putnam County Sheriff's Department, Putnam County Animal Control, Putnam County Volunteer Fire Service, and Alachua County Sheriff's Department.

The cow was able to be safely retrieved from the tank without further injury and reunited with her calf.



UF VETS recently received a generous donation from Banfield and Petsmart Charities that will greatly enhance their response capabilities. The new truck and bunk trailer will provide up to twelve sleep spaces, a bathroom, and office area for the team while operating in the field. The efficient use of space also allows this trailer to house a lot of equipment and gear during transport to keep the total number of vehicles UF VETS brings to a site to a minimum.

The team is thankful to Banfield and Petsmart Charities for providing them with this asset for future events.

Enrollment Open: Multiple Courses for Small Animal Emergency Sheltering

The Florida State Animal Response Coalition (SARC) has upcoming opportunities for their Awareness Level 1 and Operations Level 2 Small Animal Emergency Sheltering courses.

When disaster strikes, the team of trained volunteer responders will be there to shelter and protect Florida's companion animals.

The Awareness Level 1 course (FL-003-RESP) gives students the knowledge necessary to work in a small animal emergency shelter. This class provides expertise and practical experience required to become a disaster animal responder. The Operations Level 2 (FL-607) course gives many new job options, in addition to leadership skills and team-led opportunities. This course expands upon information covered in Awareness Level 1 and ICS-100 courses. Both courses are certified by the Florida Division of Emergency Management and are geared for Florida responders who want to help companion animals and their owners during a disaster.

Course topics include: Personal Preparedness, Overview of the Incident Command System, Deployment Preparedness, Assisting in Shelter Setup, Daily Care and Feeding, Proper Cage Cleaning and Disinfection, Animal Behavior, Stress Management, Zoonotic Diseases, and Personal Safety.

Pet-Friendly Sheltering Online Training Announcement



The Florida State Agricultural Response Team (SART) will soon offer an online, state-certified training on pet-friendly sheltering. The online training will provide participants with guidance on how to plan for and operate a pet-friendly shelter to ensure that individuals evacuating from a disaster with household pets are accommodated.

This training will include useful information on how to:

- Use the Incident Command System in pet-friendly shelter planning and operations;
- Create a plan for a pet-friendly shelter;
- Understand the Pets Evacuation and Transportation Standards Act (PETS Act);
- Establish partnerships for resource coordination;
- Deliver a unified message to the public before, during and after an emergency, and;
- Set up, operate and demobilize a pet-friendly shelter.

Upon successful completion of the course, participants will receive a downloadable Toolkit that offers functional guidance and plan templates, and a certificate of completion approved by the Florida Division of Emergency Management.

Food Safety and Food Defense Report

A special section dedicated to feed and food emergency planning and response.

FDACS' Division of Food Safety is responsible for assuring the public of a safe, wholesome, and properly represented food supply through permitting and inspection of food establishments, inspection of food products, and performance of specialized laboratory analysis on a variety of food products sold or produced in the state. The Division of Food Safety monitors food from the farm's gate? farm gate, through processing and distribution, to the retail point of purchase.



- Summer Williams and Steve Carmody attended the Incident Command System All Hazards Incident Commander training in Bradenton, Florida the week of April 22. Completion of this course includes certification to play the role of an Incident Commander during Incident Response. (Pictured above)
- Due to the statewide severe weather events on Friday April 19, Gilchrist and Hamilton Counties had major county-wide power outages. Some areas were without power for over 24 hours. The Bureau of Food Inspection conducted phone assessments of the Florida Department of Agriculture & Consumer Services (FDACS)-regulated food establishments in these counties to ensure the food supply was not affected.
- Emergency Support Function (ESF) 17 has been scheduling county Emergency Operations Center (EOC) meetings throughout the past few months in preparation of the 2019 Hurricane Season. At this point in time, Food Safety has covered 52 counties. The local outreach has been phenomenal!
- The Statewide Hurricane Exercise will be conducted May 6-9, 2019 at the State EOC. The Division of Food Safety will be playing a role in this exercise under ESF 17.
- Members from the Division of Food Safety attended a multi-agency meeting with other Food Regulatory agencies (FDA, USDA, DBPR, DOH, AHCA, and Elder Affairs) on April 17. Items discussed included CBD in food, a Hepatitis A outbreak update from DOH, and an overview from USDA on the Super Bowl activation in Georgia.
- Summer Williams will be presenting on Food Safety response at the Department of Health's Regional Coordinator's Meeting in Orlando, Florida on May 14th.
