SART Sponsors K9 Handler Training

Made possible by the State Agricultural Response Team (SART) and in partnership with the Florida National Guard Multijurisdictional Counterdrug Task Force and K9 MEDIC, a **K9 First Responder & Tactical Combat Casualty Care Training** was hosted on April 23rd-25th at Camp Blanding, the primary military reservation and training base for the Florida National Guard.

The training was a 3-day, 24-hour, in-person training. Topics ranged from safe K9 handling and comprehensive vital assessments to treating the most common emergencies such as heat stroke and bloat/Gastric Dilatation-Volvulus (GDV), and tactical injuries such as gunshot wounds. K9 handlers who attended the training were from a variety of jurisdictions including local, state,

and federal law enforcement and regulatory agencies. Several handlers even brought their K9 companions to the training to get hands on experience with their four-legged partner.

"By partnering with K9 MEDIC and the Florida National Guard, SART worked to bring an intense, hands-on training experience that focused on protecting and caring for canine first responders in the field, when a veterinarian or hospital isn't around," said LeiAnna Tucker, Florida SART Administrator, FDACS Division of Animal Industry. "By teaching the handler to learn and apply these emergency medical skills for their canine, they're preparing themselves for all situations, whether a missing child, a massive hurricane, or even an act of terrorism they're called to assist with."

ESF 17 Staff Continue Preparation for FAD SAFE

The Foreign Animal Disease Southern Agriculture Functional Exercise, or "FAD SAFE," is a functional exercise between 11 participating states designed to test state agricultural agency response capabilities to a multi-state Foot and Mouth Disease (FMD) outbreak. FMD is a foreign animal disease and a severe, highly contagious viral disease of livestock that has significant economic impact.

The FDACS Division of Animal Industry (DAI) will lead the FAD SAFE for Florida's response. The four-day exercise, sponsored by the U.S. Department of Agriculture (USDA), will have participation from federal, state, local, tribal, and agriculture industry representatives.

In preparation for the FAD SAFE exercise taking place on November 15-18, 2021, a series of trainings, exercises and meetings will be conducted to prepare FDACS, Emergency Support Function (ESF) 17, SART, and agriculture industry stakeholders for the FAD SAFE.

FAD SAFE 2021 Schedule

- **Monthly:** ESF 17 staff are now attending the monthly USDA Veterinary Services (VS) National Training and Exercise Program (NTEP) Multi State Working Group Call. In February's call, the work group reviewed the participating states support needs from the USDA VS National Incident Management Teams (NIMT) for the FAD SAFE exercise.
- **May:** FDACS staff will attend a combo training on Public Information Officer Foundational Skills and Joint Information Center/System to prepare ESF 17 IMT members on how to interact with media, develop public messaging, and co-responding agencies to increase situational awareness during an animal disease outbreak.
- **July:** FDACS DAI will host a Florida Livestock Movement Standstill Tabletop Exercise with industry and government stakeholders to discuss the logistics and effects of a livestock movement standstill as a result of an animal disease outbreak in Florida.
- **September:** FDACS DAI will conduct a tabletop exercise to review and test Florida's Foreign Animal Disease Emergency Operations Plan.
- **October:** FDACS DAI will conduct a "dry run" exercise before the official FAD SAFE. The dry run exercise will be held for FDACS DAI, respectively. The exercise will focus largely on entering resource and logistics requests in the USDA Emergency Management Response System (EMRS) and practicing foreign animal disease investigation that will take place during the official FAD SAFE in November.

Did you know that every year the University of Florida's Maddie's Shelter Medicine Program is tasked with providing pre and post storm disaster assistance to shelters around the state of Florida? UF coordinates with the statewide disaster response system even before the storm hits to start assessing needs and coordinating assistance.

How We Help

- Coordinate pre-storm evacuation of shelter animals to other lifesaving organizations, outside the area of the impact
- Coordinate post-storm evacuation to make room for lost pets impacted by the storm
- Coordination of medical supplies, food cages and transportation
- Link to funding for emergency grants

Hurricanes are unpredictable, so we need to prepare. One critical piece is moving animals out of the shelter in order to make room for post storm victims. The UF team has been essential in coordinating these transport efforts during Hurricanes Irma, Maria, and Michael.

To be effective, we need an emergency contact from every shelter *before* a threat is looming.



Trying to call a main shelter line during a hurricane when there is often power outages and shelter closings does not help you get the resources and assistance you need. Even cell phone service can be interrupted but social media seems to stay online more consistently. There's no need to worry, we aren't going to call just to catch up...hurricanes are serious business. Help us help you! Your contact information will be held strictly confidential.

Florida Pet-Friendly Sheltering Online Training - FREE REGISTRATION OPEN!



Course Overview

The Pet-Friendly Sheltering Online Training is the first of its kind to be offered in Florida. The training provides guidance to private, local and state entities on how to plan for and operate a pet-friendly shelter to ensure that individuals evacuating from a disaster with their household pets are accommodated. While this training will provide you with basic information and guidance, further training with local or state emergency management programs is essential to fully prepare for pet-friendly sheltering in your community. The Florida Department of Agriculture and Consumer Services developed this training collaboratively with the Florida State Agricultural Response Team (SART).

Course Objectives

- Understand the benefits of and requirements for opening pet-friendly shelters during emergency evacuations.
- Understand the concept of the Incident Command System (ICS) and how it can be applied to pet-friendly shelter planning and operations.
- Identify strategies and planning considerations for writing a pet-friendly shelter plan for all-hazards.
- Understand the benefits of establishing partnerships and Multiagency Coordination Groups with key agencies and organizations to achieve local resource allocation for pet-friendly shelter preparedness.
- Understand the critical role social media plays in emergency communications, and how to develop an accurate and effective message about available pet-friendly shelters in a disaster.
- Apply best practices when setting up a pet-friendly shelter.

Primary Audience

The target audience includes local and state government agencies, emergency management agencies, county employees, shelter volunteers, veterinary and animal care services, and persons involved with the planning and response for emergency sheltering of individuals and household pets during disasters.

Course Length

Total course length is approximately 4 hours to complete. You will be given 7 days to complete this training from the date you register. If you do not complete the training within 7 days, then your training registration will restart, and you will be required to complete the training from the beginning again.

Course Requirements

Students must pass the Final Exam to receive the certificate of completion.

Bronson Animal Disease Diagnostic Laboratory COVID-19 Services Update



Recently, the Bronson Animal Disease Diagnostic Laboratory (BADDL) experienced a critical shortage of staffing that impacted the receipt and testing of samples, particularly within the Serology Section; however on April 16, 2021, the BADDL returned to operations under a COVID-19 mission critical plan. All laboratory sections will continue to receive and process samples; however, due to limiting the number of team members at the laboratory at one time, turnaround times could vary. All reasonable efforts will be made to provide quality results in a timely manner. If your sample is urgent and you cannot afford a delayed turnaround time, please call the laboratory to discuss your processing options.

Our top priority is to continue to provide mission-critical services and superior customer service to the animal industries of Florida.

We request that clients dropping off samples in person complete the sample submission forms prior to arrival. If you need to complete the sample submission forms at the laboratory, there is a station located outside of the Receiving doorway to complete the necessary paperwork and submission forms. 

WHAT DO AMERICANS THINK ABOUT THE COVID-19 VACCINE?

In a recent survey conducted by the UF/IFAS Center for Public Issues Education (PIE Center), Americans were asked about their attitudes, beliefs and intent to receive the COVID-19 vaccine. This study was conducted between January 8 and 21, 2021 among 1,549 American adults sampled for characteristics to match the U.S. Census.


INTENT TO RECEIVE COVID-19 VACCINE

When asked about their intent to receive the COVID-19 vaccine, the majority of respondents indicated they intend to get the vaccine when it becomes available to them.



ATTITUDES TOWARD COVID-19 VACCINE

Respondents reported overall positive attitudes towards the COVID-19 vaccine. The majority of respondents indicated they believed the vaccine was useful, good, wise and beneficial.




TOP 3 PREVENTATIVE FACTORS:

- 1 POTENTIAL RISKS
- 2 ASSOCIATED COSTS
- 3 INSURANCE COVERAGE CONCERNS

Respondents were asked what factors would prevent them from receiving a COVID-19 vaccine. Potential risks, associated costs and insurance coverage concerns were the most reported preventative factors.

When asked what would influence their decision to receive a vaccine, respondents indicated medical risks, concerns about unknown long-term risks and level of trust in pharmaceutical companies were the most influential deciding factors.

Data was collected between January 8 and 21, 2021 by the UF/IFAS Center for Public Issues Education. This survey was conducted among 1,549 adult Americans sampled for characteristics to match the U.S. Census.

Food Safety and Food Defense Report

A special section dedicated to feed and food emergency planning and response.

Florida Department of Agriculture and Consumer Services' (FDACS) Division of Food Safety is responsible for assuring the public of a safe, wholesome, and properly represented food supply through permitting and inspection of food establishments, inspection of food products, and performance of specialized laboratory analysis on a variety of food products sold or produced in the state. The Division of Food Safety monitors food from the farm gate, through processing and distribution, to the retail point of purchase.

Severe Weather Blows Roof off Food Establishment

Even though Florida can see tornadoes and severe weather year-round, the strongest and deadliest tornadoes in Florida's history have occurred in the late winter and early spring, generally from January through April. Did you know Florida ranks 4th nationally in the annual average number of tornadoes (trailing Texas, Oklahoma, and Kansas, and tied with Nebraska)? In 2020, there were 65 tornadoes in Florida.



Florida was threatened with severe weather statewide the weekend of April 10-11. During this time, there was a total of six reported tornadoes: three in Bay County, one in Walton County, one in Manatee County, and one in Polk County. The Division of Food Safety had 20 regulated entities in the vicinity of the Bay County tornadoes. All other tornadoes were very small and only occurred in residential areas. Inspectors conducted phone and on-site assessments at these entities; with some noting building damage including one convenience store with an entire roof lost and over \$70,000 worth of food product destroyed in Panama City Beach. Oddly enough, the roof was lifted off the convenience store and landed on a nearby home. Luckily there were no injuries.

In addition, a report was received from the State Emergency Operations Center for a damaged water facility in Brooksville affecting another convenience store. The Division of Food Safety issued a stop sale on all food processing due to a damaged well head and minimal water pressure with no boiled water procedures (store had already discontinued beverage service and closed restrooms).

SART Sponsors K9 Handler Training (continued)



The Florida Department of Agriculture and Consumer Services (FDACS) had representation from the Division of Plant Industry (DPI). You may be wondering why DPI has K9 handlers. FDACS/DPI canines search shipping hubs for material that may carry invasive plants and diseases, patrol for contraband agricultural products in airline passengers' luggage. DPI canines even have noses that are tuned to detect the scent of invasive pests such as the giant African land snail, which has been the subject of eradication efforts in Miami-Dade County since 2011. The training prioritized COVID-19 safety by requiring masks and temperature checks every day. SART looks forward to sponsoring this valuable training again in the future.
