FDACS Hosts Movement Standstill Virtual Tabletop Exercise

On July 27-29th, the Florida Department of Agriculture and Consumer Services (FDACS) Division of Animal Industry hosted a Movement Standstill Virtual Tabletop Exercise as a preparatory event for the Foreign Animal Disease Southern Agricultural Functional Exercise (FAD SAFE) that will take place in November.

"A tabletop exercise involves key personnel discussing simulated scenarios in an informal setting," said FDACS' Nick Morrow. Tabletop exercises are often used to assess and update plans, policies, and procedures.

"The purpose of the Movement Standstill Virtual Tabletop Exercise was to test Florida's plan to support a request from the United States Department of Agriculture (USDA) for a national animal movement

standstill, in response to a Foot and Mouth Disease outbreak," said Morrow.

A national animal movement standstill is the temporary prohibition of the initiation of any new movement of a susceptible species in a country. The Stop Movement Virtual exercise was well attended and engaged over 45 key stakeholders, including regulatory agencies such as FDACS and USDA, industry stakeholders such as the Florida Cattleman's Association, the Florida Association of Livestock Markets, and Southeast Milk, Inc., and law enforcement officials such as the Florida Fish and Wildlife Conservation Commission and FDACS' Office of Agricultural Law Enforcement.



Movement Standstill Virtual Tabletop Exercise (continued)



These stakeholders worked together to solve the challenges presented by a stop movement order. Critical activities discussed during the exercise were incident management, quarantine and movement control, communication, animal welfare, continuity of business, biosecurity, and epidemiological investigation and tracing.

The exercise was a success. The facilitated discussion, led by USDA and FDACS staff, and input from key stakeholders helped to achieve the goal of the exercise, which was to identify gaps and/or areas for improvement in Florida's existing "Draft" Foreign Animal Disease Emergency Operations Plan (EOP). The exercise was evaluated by a multiagency team with representation from the University of Florida College of Veterinary Medicine, the Florida Division of Emergency Management, the University of Florida Institute for Agricultural Science Extension Service, and FDACS. Considering gaps discovered in Florida's FAD EOP, the plan will be updated in preparation for the next FAD SAFE preparatory event which will take place in September.

Florida Pet-Friendly Sheltering Online Training - FREE REGISTRATION OPEN!



Course Overview

The Pet-Friendly Sheltering Online Training is the first of its kind to be offered in Florida. The training provides guidance to private, local and state entities on how to plan for and operate a pet-friendly shelter to ensure that individuals evacuating from a disaster with their household pets are accommodated. While this training will provide you with basic information and guidance, further training with local or state emergency management programs is essential to fully prepare for pet-friendly sheltering in your community. The Florida Department of Agriculture and Consumer Services developed this training collaboratively with the Florida State Agricultural Response Team (SART). This training is state-certified by the Florida Division of Emergency Management (Course Code FL-017).

Course Objectives

- Understand the benefits of and requirements for opening pet-friendly shelters during emergency evacuations.
- Understand the concept of the Incident Command System (ICS) and how it can be applied to pet-friendly shelter planning and operations.
- Identify strategies and planning considerations for writing a pet-friendly shelter plan for all-hazards.
- Understand the benefits of establishing partnerships and Multiagency Coordination Groups with key agencies and organizations to achieve local resource allocation for pet-friendly shelter preparedness.
- Understand the critical role social media plays in emergency communications, and how to develop an accurate and effective message about available pet-friendly shelters in a disaster.
- Apply best practices when setting up a pet-friendly shelter.

Primary Audience

The target audience includes local and state government agencies, emergency management agencies, county employees, shelter volunteers, veterinary and animal care services, and persons involved with the planning and response for emergency sheltering of individuals and household pets during disasters.

Course Length

Total course length is approximately 4 hours to complete. You will be given 7 days to complete this training from the date you register. If you do not complete the training within 7 days, then your training registration will restart, and you will be required to complete the training from the beginning again.

Course Requirements

Students must pass the Final Exam to receive the state-certified Certificate of Completion.

The Florida State Animal Response Coalition (FLSARC) has upcoming opportunities available for their Awareness Level 1 and Operations Level 2 Small Animal Emergency Sheltering courses.

FLSARC provides emergency animal sheltering training for Florida, its counties, and communities. These courses teach the unique procedures, skills, and knowledge necessary to build and operate a temporary emergency animal shelter in response to natural disasters and large cruelty cases. These courses were created and designed by experts from many organizations including Florida SART, University of Florida Veterinary Emergency Treatment Service Team, and leadership of FLSARC. Both courses are state-certified by the Florida Division of Emergency Management.

The Awareness Level 1 course (FL-003-RESP) gives students the knowledge necessary to work in a small animal emergency shelter. This class provides expertise and practical experience required to become a disaster animal responder. The Operations Level 2 (FL-607) course gives many new job options, in addition to leadership skills and team-led opportunities.

AWR 328: All Hazards Preparedness for Animals in Disasters-Virtual Zoom Delivery

This 8-hour, tuition-free, DHS/FEMA-certified course will provide livestock producers, emergency managers, veterinarians, extension agents, veterinary technicians, rural community leaders, public and human health personnel, fire and law enforcement with tools to protect, respond to, and recover from the consequences of disasters e.g. fire, flood, heat, earthquake, tornadoes, hurricanes, hazardous materials and catastrophic disease exposure involving animals in rural communities.

The course will introduce participants to the unique issues that must be considered and addressed when animals are involved in an emergency such as safe animal handling, animal evacuation, animal sheltering, humane euthanasia and carcass disposal, inclusion of animal management into existing ICS structures, federal support available during recovery, and unique considerations for conducting jurisdictional assessments and mapping evacuation routes. All content will be presented at an in-person workshop that will include didactic presentations by expert instructors, and small-group, hands-on, problem-solving activities that will be completed by participants.

More than 100 Florida Forest Service Firefighters and Support Personnel Now Deployed to Western Wildfires

Last month, Florida Agriculture Commissioner Nikki Fried and the Florida Forest Service (FFS) announced the deployment of an additional 20-person Type 2 initial attack hand crew to Montana to support ongoing wildfire suppression efforts. On July 14, the National Preparedness Level was elevated to five, which indicates the highest level of wildfire activity. According to the National Interagency Fire Center, there are currently more than 21,500 wildland firefighters and support personnel and 28 incident management teams assigned to at least 82 large wildfires that have burned nearly 1.7 million acres across 13 states. Lipari Foods is Recalling Dried Apricots Because They May Contain Undeclared Sulfites

Lipari Foods of Warren, Michigan is recalling 86 cases of Troyer Manufacturing Backroad Country Dried Apricots because it may contain undeclared sulfites. People who have an allergy or severe sensitivity to sulfites run the risk of serious or life-threatening allergic reaction if they consume these products. Commissioner Fried & FDACS: Add a Fuel Plan to Hurricane Preparations

Commissioner Nikki Fried and FDACS are strongly encouraging Floridians to consider adding a fuel plan to annual hurricane preparations. Surges in consumer demand due to hurricanes can cause disruptions in Florida's fuel distribution system. Early preparation by consumers will reduce the strain on fuel distribution, ensure fuel is available as needed, and reduce the cost of fuels that can increase due to sudden higher demand. "We have all seen how panic-buying and sudden surges in demand for gas can cause disruptions to the fuel supply – which unfortunately happened earlier this year following the cyberattack on the Colonial Pipeline," said Commissioner Fried. CONSIDER ADDING A FUEL PLAN TO YEARLY HURRICANE PREPARATION



Surges in consumer demand due to hurricanes can cause disruptions in Florida's fuel distribution system. Early preparation by consumers will reduce the strain on fuel distribution and will help ensure that fuel is available as needed.

SOME TIPS



- Keep all vehicles at least half full during hurricane season.
- Keep at least one vehicle filled with gasoline once the earliest predictions indicate a storm may threaten the state.
- Pre-purchase fuels (LP gas and gasoline) for generators at the start of hurricane season.
- Use gasoline fuel stabilizer to keep gasoline fresh and ready to use when it is needed.
- Properly stored fuels can be safely stored throughout hurricane season, and can be transferred into vehicles for use, should no emergency arise.

FUEL SAFETY



- Refill fuel containers on the ground, not in the truck bed or trunk.
- Transport and store fuel ONLY in appropriate containers- look for DOT approved containers that close tightly and do not leak.
- NEVER store or transport gasoline in milk jugs or open top containers!
- Store fuel in a safe and well-ventilated location.

TYPICALLY FUEL CONTAINERS ARE COLOR CODED FOR VARIOUS FUELS:

- Red containers are intended for gasoline and other highly flammable liquids.
- Blue containers are used for storing kerosene.
- Yellow containers are used for diesel fuel.
- Green containers typically are designed for storing oil.

- 145°F** – fish and whole cuts of beef, pork, lamb, and veal (with a stand time of 15 seconds at this temperature).
- 155°F** – hamburgers and other ground meat or fish products.
- 165°F** – poultry and wild game meats such as venison.

Did you know that every year the University of Florida's Maddie's Shelter Medicine Program is tasked with providing pre and post storm disaster assistance to shelters around the state of Florida? UF coordinates with the statewide disaster response system even before the storm hits to start assessing needs and coordinating assistance.

How We Help

- Coordinate pre-storm evacuation of shelter animals to other lifesaving organizations, outside the area of the impact
- Coordinate post-storm evacuation to make room for lost pets impacted by the storm
- Coordination of medical supplies, food cages and transportation
- Link to funding for emergency grants

Hurricanes are unpredictable, so we need to prepare. One critical piece is moving animals out of the shelter in order to make room for post storm victims. The UF team has been essential in coordinating these transport efforts during Hurricanes Irma, Maria, and Michael.

To be effective, we need an emergency contact from every shelter *before* a threat is looming.

Please follow the link to our form below to provide your shelter's point of contact, a direct line for that contact, a cell phone number and a social media/messenger connection. Why a cell phone and messenger contact? Trying to call a main shelter line during a hurricane when there is often power outages and shelter closings does not help you get the resources and assistance you need. Even cell phone service can be interrupted but social media seems to stay online more consistently. There's no need to worry, we aren't going to call just to catch up...hurricanes are serious business. Help us help you! Your contact information will be held strictly confidential.
